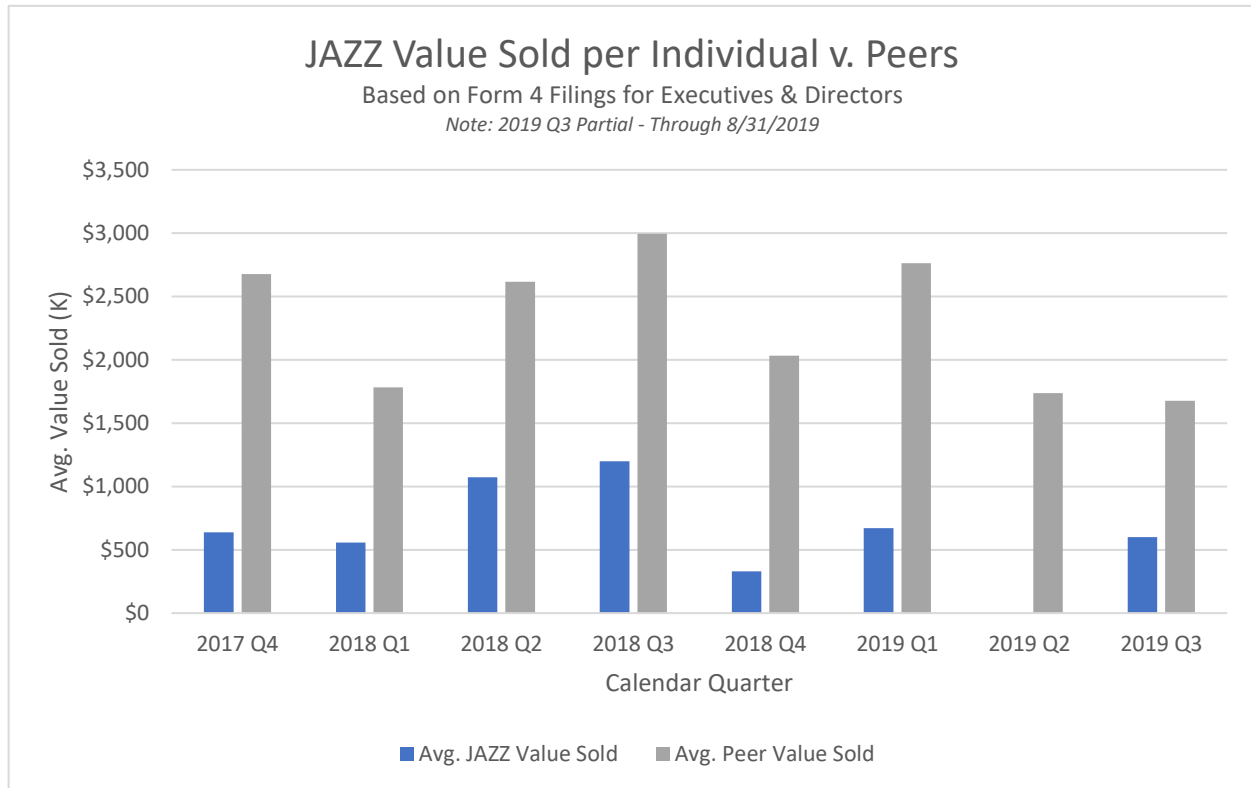

Jazz Pharmaceutical Plc (JAZZ) is a mid-cap biopharmaceutical company that focuses in products for narcolepsy, oncology, pain, and psychiatry. Executives and directors at JAZZ are generally less active sellers than their industry peers as seen in the below chart. In the last 24 months, 57% of their sales involved restricted stock and 76% of their sales occur under Rule 10b5-1 plans.

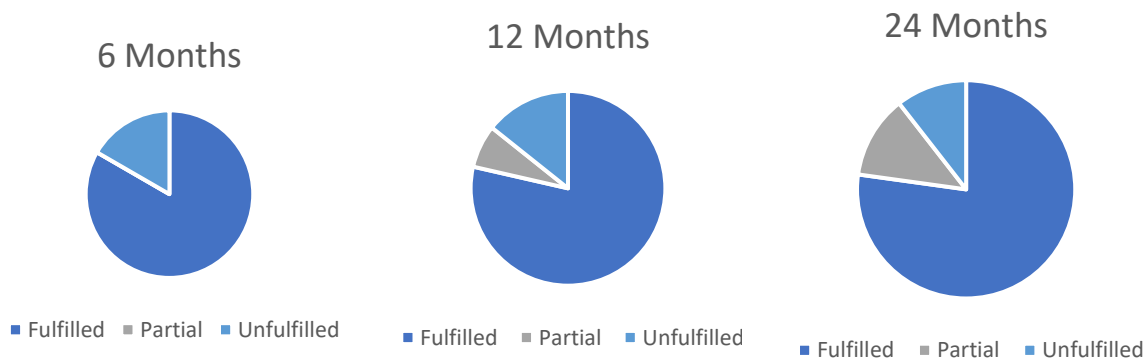

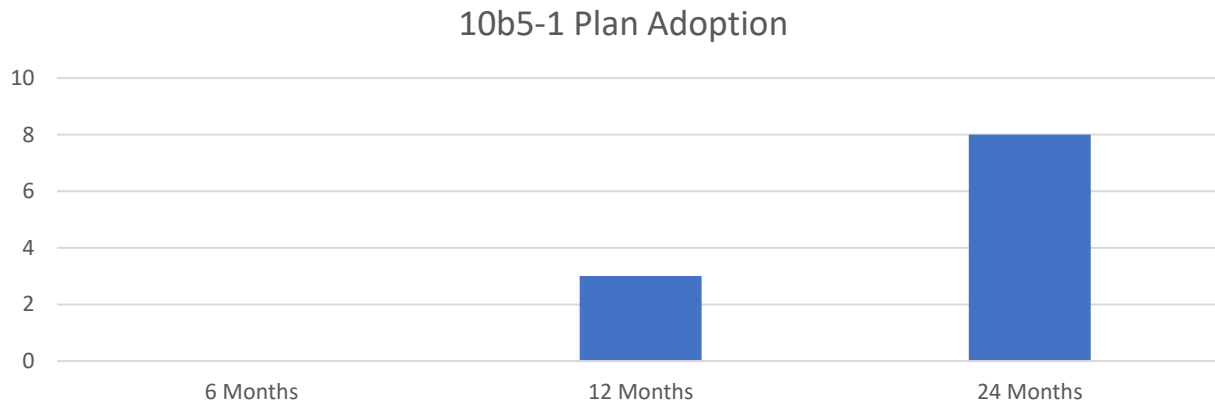

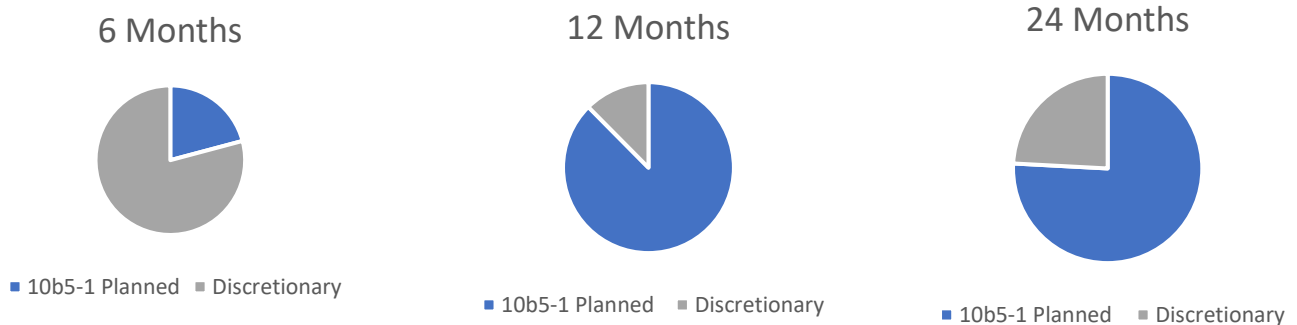

10b5-1 Penetration – planned sales v. discretionary sales

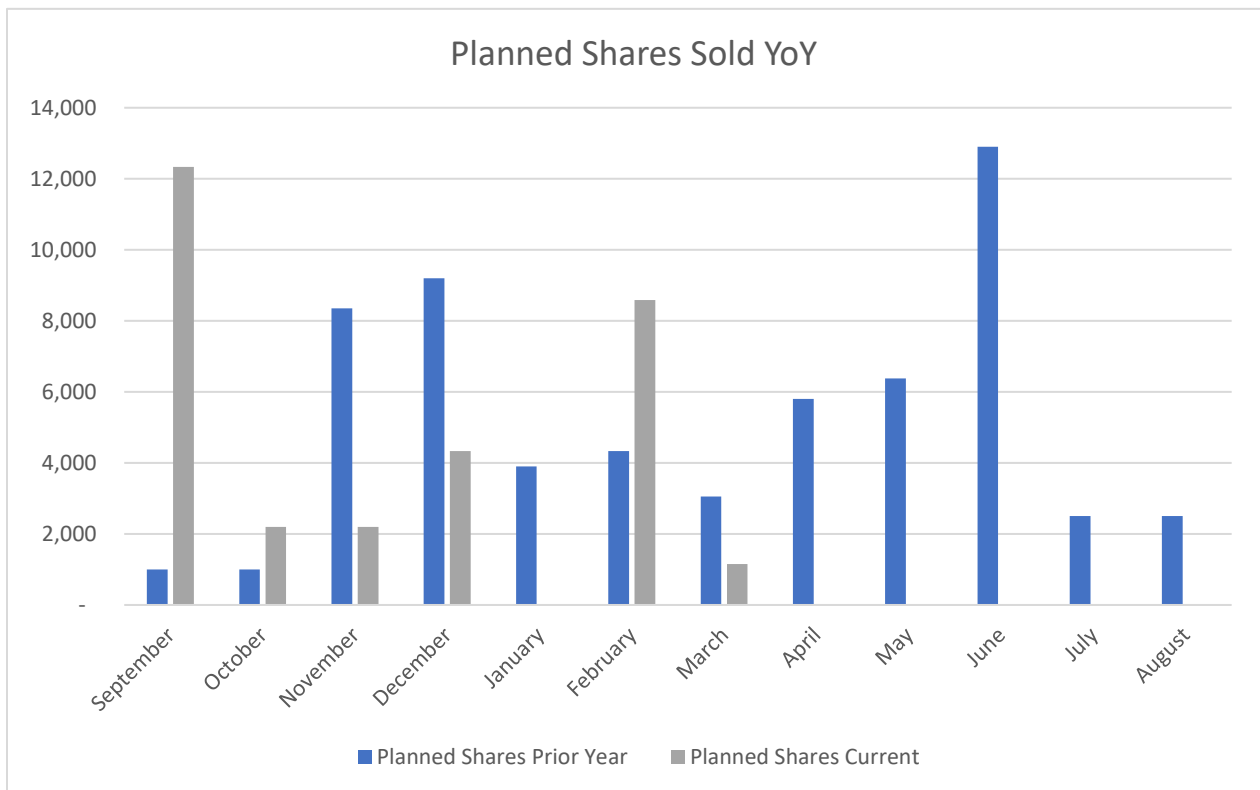
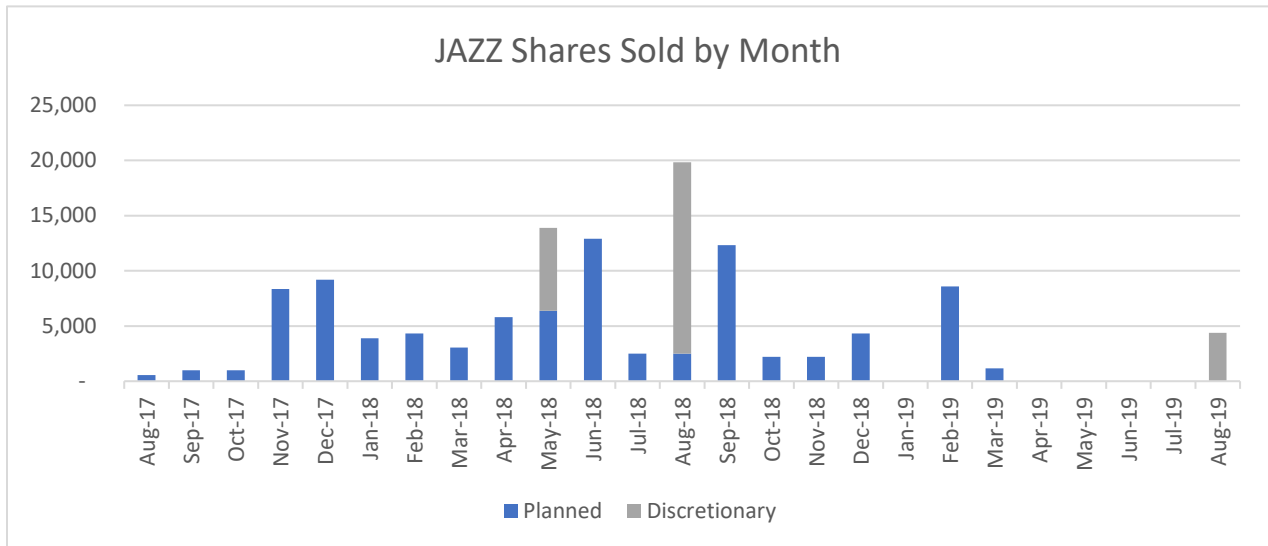
